Because Aaron L. Hammer, 37, reaches milestones so quickly, few people are surprised he already leads the bankruptcy practice at Freeborn & Peters LLP.

At age 25 while a first-year associate, Hammer began teaching as an adjunct law professor at Northwestern University School of Law. He is reportedly the youngest faculty member in the law school's 160-year history.

Before Hammer turned 30, he led a Mayer Brown legal team representing the debtor in the complex Chapter 11 proceedings of Lason, Inc. in Delaware. The matter concluded with the successful reorganization of a \$200 million annual revenue multi-national business in May 2002. Several months later, Hammer began representing Philip Morris in United Airlines' Chapter 11 proceeding on over \$250 million in leveraged aircraft leases. Following the successful conclusion of this matter for his client, Hammer advised aircraft financiers and purchasers in virtually every major airline restructuring this decade including American, Atlas, ATA and Delta airlines.

At age 33, Hammer accepted Freeborn & Peters' invitation to join its bankruptcy practice as a partner. After helping grow the team to ten full-time professionals, at age 36, Hammer was named practice group leader. "Aaron has achieved many unique and exceptional things in his relatively short 12-year career as a corporate reorganization and bankruptcy attorney," says William N. Cohen, national leader of the restructuring practice at Gowling Lafleur Henderson in Canada says Hammer is "a world-class practitioner of cross-border workouts and corporate restructurings" who recently "received praise from a federal bankruptcy judge as 'the expert' in Chapter 15 proceedings under the U.S. Bankruptcy Code." Weeks later, INSOL Europe cited Hammer's latest publication on the subject to the U.S. Supreme Court in another cross-border insolvency matter.

Mark S. Melickian of Drinker Biddle says Hammer "has consistently shown outstanding lawyering ability, innate instincts in the bankruptcy arena and a practical approach to resolving his client's issues." Even as a junior associate, says Melickian, Hammer was part of the team that successfully represented Bank of America before the U.S. Supreme Court in 203 N. LaSalle St. Partnership, a seminal bankruptcy case.

In May 2009, he was awarded "Large Transaction of the Year" from the Turnaround Management Association's Chicago/Midwest chapter for his role as creditors' committee counsel in the Chapter 11 cases of Trinsic Communications, Inc., in Alabama - a prestigious honor for this emerging industry leader.
